

# 2010 OSB ENTRY FORM

1. TO BE HELD AUGUST 6<sup>TH</sup> THRU AUGUST 11<sup>TH</sup>, 2010 AT THE FLYING C BAR RANCH ARENA LOCATED AT DEPEW, OKLAHOMA.

2. THE NON PRO DIVISION IS A SEPARATE CONTEST AND A CONTESTANT MAY, IF CHOOSES, ENTER ONLY THE NON PRO DIVISION. THE OWNER OR AN IMMEDIATE MEMBER OF HIS FAMILY MUST SHOW THE HORSE IN THE NON PRO DIVISION.

3. UNLIMITED NUMBER OF HORSES MAY BE RIDDEN.

4. THE OPEN AND NON PRO DIVISION WILL CONSIST OF ONE GO ROUND AND FINALS. DEPENDING ON THE NUMBER OF ENTRIES IN CLASS, ADVANCEMENT AND FINALS WILL BE AS FOLLOWS:

- 1-10 4 HORSE FINALS WILL PAY 4 PLACES
- 1-15 5 HORSE FINALS WILL PAY 5 PLACES
- 16-25 8 HORSE FINALS WILL PAY 8 PLACES
- 26-45 10 HORSE FINALS WILL PAY 10 PLACES
- 46-60 12 HORSE FINALS WILL PAY 12 PLACES
- 61-75 15 HORSE FINALS WILL PAY 15 PLACES

5. THERE WILL BE 2 "AAA" JUDGES. COMBINED SCORE OF ALL JUDGES.

6. IT IS THE SOLE RESPONSIBILITY OF THE OWNER AND RIDER OF ANY ENTRY TO BE IN THE ARENA AT THE PROPER TIME TO SHOW THEIR ENTRY.

7. FLYING C BAR RANCH ARENA RESERVES THE RIGHT TO ACCEPT OR REJECT ANY ENTRY. ALL DECISIONS OF THE ARENA ARE FINAL. FLYING C BAR RANCH ARENA RESERVES THE RIGHT TO CANCEL THIS EVENT WITHOUT NOTICE ANYTIME TO THE CONTESTANT WITHOUT LIABILITY TO THEM, BUT IN SUCH EVENT, RETURN ALL MONEY.

8. ALL ENTRIES ENTER THE FLYING C BAR RANCH ARENA. WITH THE KNOWLEDGE THE FLYING C BAR RANCH ARENA WILL DECIDE CONTROVERSIES OR CONFLICT ALL ENTRIES AGREE TO ABIDE BY SUCH DECISION.

9. STALL FEE FOR THE ENTIRE SHOW WILL BE \$110 PER HORSE NON-REFUNDABLE. SHAVINGS INCLUDED. STALLS MUST BE PREPAID.

10. RV-\$25 PER NIGHT FOR WATER AND ELECTRIC. LIMITED SPACES AVAILABLE, PLEASE CALL TO RESERVE.

11. ENTRY FEES AS FOLLOWS:

- 3,4 & 5 YR OLD OPEN EF\$275 CCS\$275 OCS\$50 (PRORATED OPEN & NP)
- 3,4 & 5 YR OLD NP EF\$275 CCS\$275 OCS\$50 (PRORATED OPEN & NP)
- OSB OPEN PURSE \$18,000 CCS\$350
- OSB NON PRO & AMT PURSE \$11,500 CCS\$350

12. ENTRIES WILL CLOSE AUGUST 5, 2010; DRAW WILL BE MADE AT 3:00. P.M ON AUGUST 6, 2009. ADD ON WILL BE PERMITTED PRIOR TO CLASS.

13. ALL RULES OF NATIONAL CUTTING HORSE ASSOCIATION WILL APPLY, NOT IN DIRECT CONFLICT WITH THE RULES OF THE FLYING C BAR RANCH ARENA, OKLAHOMA EARLY BIRD FUTURITY AS PUBLISHED OR AMENDED. RULE #14 SHALL APPLY.

14. THESE RULES ARE SUBJECT TO CHANGE AT ANY TIME BY ACTION OF FLYING C BAR RANCH ARENA, OKLAHOMA EARLY BIRD FUTURITY.
